EnSpray 99® - Spraying Oil 200ml

ACTIVE INGREDIENT: Contains 821g/L (980ml/L) mineral oil in the form of an emulsifiable concentrate. Unsulphonated residue not less than 99.0%. **HSNO HAZARD CLASSIFICATION:** 6.1E, 6.3B, 6.4A, 9.1D. Do not allow spray to drift onto aquatic environments, other crops or desirable plants or outside the target area. RESTRAINTS: Do not spray under conditions that cause slow drying: i.e. low temperatures, high humidity. Do not spray in the late evening or early morning or during the hours of darkness: this could cause damage to the fruit.

PLANTS	USE	RATE
Deciduous plants: Apples, pears and stonefruit	For control of European red mite, San Jose scale, aphids and powdery mildew	15-20ml per litre of water. For scale control apply during dormant period up until green tip
Citrus	For the control of scale insects, aphids, citrus red mite, thrips and powdery mildew	10ml per litre of water
Evergreen Plants: Roses and Ornamentals	For the control of European red mite, mealy bug, scale insects, aphids and powdery mildew

Indoor plants	Leaf polish. Apply with a soft cloth	5ml per 200ml (1 cup) of water.
