Theraplay Supervision and Certification

Interested in Taking your Theraplay® Training to the Next Level?

Many graduates of Level One Theraplay & MIM training go on to join The Theraplay® Institute's certification practicum. In the practicum, students are matched with and guided by a Certified Theraplay Supervisor. Certified Supervisors have a minimum of two years of experience as a Certified Theraplay Practitioner and have completed a rigorous practicum to become a supervisor. Many supervisors are trained in a variety of modalities and are leaders in their field. Supervision at The Theraplay® Institute is designed to provide you with the highest level of professional support as you acquire skills and knowledge about the Theraplay modality. We recommend completing Foundational certification for minimum best practice.

The Benefits of Adding Theraplay to Your Practice

Theraplay is an essential treatment modality for professionals who work with children and families. Theraplay focuses on the "here and now", and can provide results that cannot be obtained from talk therapies or traditional non-directive play therapy.

As an intervention, Theraplay:

- Provides a way of working with young children that is interactive and relationship based
- Addresses attachment issues faced by biological, foster and adoptive families
- Involves the caregiver in the treatment; practicing leadership, responsiveness, attunement, empathy and reflection
- Works with children who are non-verbal or that have developmental delays, the play is designed to meet the child at their level of emotional development
- Breaks through to resistant and oppositional children by working with their resistance playfully
- Achieves a quick change in the relationship dynamic of families that are stuck in negativity, often in the first few sessions

Theraplay Practitioners have found that Theraplay easily integrates with other treatment modalities such as DDP and EMDR. One supervisor stated, "Theraplay supervision will give you a theory base and techniques that go with it that you won't get anywhere else. You will get a foundation for all other methods you endeavor to learn."

We are now offering dyadic and cohort supervision options to earn a Foundational Theraplay Practitioner certificate. The dyadic option includes 2 students meeting 12 times for one hour of online supervision. Each member presents 6 times and observes 6 times. With the cohort option 4 students meet 8 times for two hours of group supervision via the internet. Over the course of the 8 meetings, each member presents 4 cases and participates in the observation of 12 others.

Protocol Summary

Step 1 Complete Level I Training

Step 2 Register for Practicum

Send registration fee, copy of practicum attestation, license, resume or vita, proof of professional liability insurance and permission from supervisor to robin@theraplay.org. Case materials (MIM and first family session) are sent to your supervisor - we will assign one if you have not made prior arrangements.

Step 3 Complete Foundational Practitioner requirements

Total of 8 supervised and 32 unsupervised sessions.
Certification requires recommendation of supervisor

Step 4 Complete Intermediate Practitioner requirements

8 supervised and 32 unsupervised sessions*
8th session submitted is considered your Intermediate review and is sent to TTI
Certification requires recommendation of supervisor

Step 5 Complete Level Two Training

Can be done at any time during the first half of the practicum
The training is also open to any Level One graduate; practicum membership not required

Step 6 Full Certification

8 supervised and 32 unsupervised sessions*
Last session submitted is considered your Final review and is sent to TTI
Certification requires recommendation of supervisor

Getting Started



My name is Robin Shannon and I am the Practicum Manager. I can answer specific questions about supervision options, levels of certification or make suggestions about supervisor matches. I am also who you will contact to register for the practicum and I will help keep track of your progress, eventually sending you your certificates. I coordinate practicum cohorts and dyads, and coordinate online monthly supervision. I am usually available Tuesday-Thursdays by phone or email to answer any questions.

Educational Requirements

- A master's degree or higher in a mental health field specializing in working with children and families
- Licensure that allows you to work independently

In countries that do not follow the U.S. education and licensing model, applicants will be asked to demonstrate education equivalent to the above: they must work independently and take responsibility for the welfare of their clients according to the rules of their country.

Those who have other qualifications or specialties working with children may earn up to the Foundational level of certification. There is also a practicum for Group Therapy Practitioner. Please contact us for further information.

Training Requirements

- Level One Theraplay & MIM: Complete four day training (price subject to change).
Price includes textbook and 2 free web supervision observations.

- Level Two Theraplay & MIM: Complete three day training and supervision (prices subject to change).

Fees are pay as-you-go by certificate level, you do not need to commit to completing the entire program. Scholarship funds may be available

*Fees must be paid prior to undertaking supervision in each level. Upon starting the practicum, all fees non-refundable. If you have not yet started the program and would like a refund, there is a \$200 processing fee.

**If using an independent supervisor, only the registration fee is required to begin each level of certification.

After registering, independent supervisors are paid directly for supervision.

Practicum Summary

- Total number of supervised sessions: 24 minimum
- Total number of unsupervised sessions: 96
- Total number of Theraplay cases: 7 minimum
- Time to complete program: 1 year minimum for full certification
- Cost of full certification is \$3350.

Supervision Methods

- Independent Supervision can be provided by Certified Theraplay Supervisors in person or via secure internet file sharing and video conferencing, or by mailing DVDs or thumb drive
- The Theraplay Institute offers organized groups of two or four for students who want to achieve Foundational status more quickly for less money. Please contact us for more information or visit our website to download a flyer with more information. We also encourage students to organize Theraplay peer support groups or to receive group supervision from us on an “as needed” basis. Commitment to the practicum is not required.
- Web Supervision is offered twice a month and provides an opportunity to either present to a group over the internet or to observe another practicum student present their case. The first two observations are free after completing Level One training and, practicum students may earn credit towards certification by presenting a case online.
