Dear Members,

Attached is an outline of the fee structure for the 2018/19 season.

The following charges are the fixed costs, inclusive of GST, and are non-refundable. These fees will be charged once yearly to all members.

FIXED COSTS

Intent To Play	\$50
Basketball SA and Basketball Australia Levies	\$22.20 (Under 10, 12) \$29.90 (Under 14 to Under 18) \$37.70 (Youth League & Senior)
Balance of Fixed Cost	\$55

Once you accept an offer to play for Sturt by completing an 'Intent To Play' form, then full fees will be charged, even if you later decide not to play. Refunds and prorated amounts will only be given under exceptional circumstances and will not be given if a player reneges on their commitment to the team, other team members and club. Any refunds that are assessed and granted will be calculated on variable costs only.

VARIABLE COSTS

Variable costs are determined by the cost to provide practices and club administration. The club absorbed price rises (for court hire and affiliation fees) for 2018, continued increases for 2019 means that we have to pass on some of these costs for 2019.

In recognition of loyalty and long-term commitment, the Club has also decided to reduce the cost of playing Youth League and Seniors for Sturt, in particular, those in lower divisions. This brings Sturt more into line with the fees other clubs are charging players who have graduated from the junior programs.

The Club will endeavour to issue invoices by the third week of a season and payment terms will be 28 days from the date of the issue of the invoice.

Payment plans will be available for members who request this option. A request for a payment plan will need to be submitted to the Finance & Administration Officer no later than two weeks (14 days) before the due date of the season fees. Payment plans will now be set up as direct debits through a third-party provider and fees for non-payment or late payment will be added.

The “No Pay No Play” will be enforced if fees are not paid, or payment plans instalments are not made in a timely manner.
